## Location

The surrounding area is predominately residential in nature with estates such as Ashgrove, Ard Na Laoi, Drumalee Manor and Rocklands.












# **Description**

The subject property comprises a substantial greenfield landholding which is currently in agricultural use. The site extends to a total landholding of approximately 4.78 hectares (11.8 acres). The N3 (Belturbet/Enniskillen Road) adjoins the lands to the east. An existing access point is provided off the Drumalee Road directly opposite the entrance to the Drumalee G.A.A grounds. The Cootehill Road is situated approximately 300 metres to the west.





## **Town Planning**

The property is subject to two distinct land use designations within the Cavan Town Local Area Plan 2022-2028:

- The front (western) portion is zoned 'Proposed Residential' –
  Approx. 6.0 acres
- The rear (eastern) portion is zoned 'Residential Strategic Reserve' Approx. 5.8 acres

The Cavan Town LAP indicates an average density of 8 units per acre on lands zoned 'Proposed Residential'.
